Agenda topic HOA Board of Directors Election | Presenter Mark Petrakis

There are three open positions on the HOA Board of Directors. There was one nomination – Monty Wood. Wood ran unopposed and was re-elected to another three-year term on the Board. Wood's term will run through 2026.

Richard Burch and Rick Brinkley both agreed to stay on the Board for another year because of the lack of candidates to replace them. Vice President Doss said his job will take him to Alaska next spring, and he will be moving out of the neighborhood. This will create another opening on the Board.

Landownership Issues

The Board is trying to obtain clear ownership of Open Space C and Residue C & D on the neighborhood map. Residue C & D and Open Space C are still in question, as well as Dark Star Lane and the Future Right of Way (near the circle). Residue B is now in Chesapeake Village's name. We are working with Haskell & Zimmerman to help with this. We are still trying to obtain a quick claim deed from Quality Built Homes and Over Water LLC.

Haskell & Zimmerman say they are working on the case.

Common Areas

The landscaping contractor, Greener Visions, submitted a three-year contract for snow-and-ice removal. The deal was approved.

There was a report from the Town of Chesapeake Beach that said the Boy Scouts planted trees on Dark Star Lane. We have noticed no new trees along this lane. The Board concluded that the planting must have occurred inside the fenced in area near the water tower.

Greener Vision agreed to replace two dogwood trees down along Bayside Road, trim the trees on the entrance hill, and replace a missing elm tree along Chesapeake Village Boulevard.

The overgrown brush on the guardrail near the entrance has been cleaned up.

A new pet waste can has been installed near Dark Star Lane, replacing the damaged one.

Complaints

There was a complaint about common area overgrowth behind 7214 Chesapeake Village Boulevard. The landscaping contractor has cleaned up this area.

Committees

Community Improvement Committee: We are waiting on Part 2 of the drawings from the land space architect (Anik Jhaveri, KOr.10). Jayson Frum said he would contact Anik.

Social Committee: The Social Committee chair position remains vacant. The Board would like to fill this position as soon as possible. The annual block party scheduled for October 7 was canceled because of poor weather.

Welcome Committee: New homeowners at 3366 Cannoncade Court (Williams).

HOA Covenants Review Committee: If Open Space C becomes Chesapeake Village property, we will need to update the covenants with that information. If that happens, it would be an ideal time to update other parts of the covenants.

Luminaries Committee: The next event is scheduled for December 9, 2023. This is the last year that Ryan Doss will coordinate the event.

Architecture Review Committee

The HOA Board recognizes there should be an Architecture Review Committee consisting of members who are not on the HOA Board. Right now, the HOA Board members are doubling as the Architecture Review Committee. There should be an effort to solicit homeowners to serve as committee members.

Approvals for projects should also include a note that homeowners are responsible for any permits that may need to be obtained from the Town of Chesapeake Beach or Calvert County or the State of Maryland.

Note: The HOA Board will not approve fences, decks, exterior improvements, etc., if the homeowner is "not in good standing," meaning the homeowner has an outstanding inspection violation or has a delinquent account. Also, homeowners will not receive the \$50 annual dues discount if the homeowner is "not in good standing."
