Annual Homeowners Meeting/Block Party Set for Oct. 9 on Cannoncade Cul-De-Sac

Are you ready to rock? Of course you are! The rock band Hot Ice is scheduled to play as part of the annual Homeowners Association member meeting/block party Oct. 9 at the Cannoncade Court cul-de-sac.

First, beginning at noon, will be the annual HOA members meeting and election for two open positions on the HOA Board of Directors. The HOA Board of Directors consists of five volunteers from the village who serve three-year terms. Their terms are staggered over a three-year period. We need 25 percent of the homeowners present for a quorum for the election (55 of 218 homes). Bring your chairs and participant in your homeowners association! If a quorum is not reached, there will be a new vote at the November Board of Directors meeting, and that vote at that meeting will be valid.

FRIENDLY REMINDERS

Keep Your Trash and Recycling Receptacles Out of Sight

According to the HOA covenants, all trash and recycling containers "shall not be permitted to remain anywhere in view from public roadways except on days of trash collection."

P. Trash Receptacles and Storage; Firewood. Garbage, trash and other refuse shall be placed in covered containers. Trash and garbage containers shall not be permitted to remain anywhere in view from public roadways except on days of trash collection.

Firewood must be stored in the rear yard area of the Lot or in an approved screened area and must be stacked to a height of no more than four (4) feet. The screened area shall not be erected, used or maintained on any Lot at any time without first obtaining the written approval by the Board of Directors.

No Parking on the Sidewalks

The Town of Chesapeake Beach reminds us that parking on sidewalks within the town limits is against town code and subject to a \$100 fine per day. The HOA covenants also say that "no ... wheeled vehicles or toys shall be parked or left unattended on any sidewalk, pathway, or walkway or on any part of the roadways or other common areas ..."

R. Parking and Traffic Restrictions. No automobile, motorcycle, bicycle, tricycle, or other wheeled vehicles or toys shall be parked or left unattended on any sidewalk, pathway, or walkway or on any part of the roadways or other Common Areas of the Property so as to interfere with or obstruct the use thereof or ingress and egress to any Lot, such roadways, or the Common Areas. Except as expressly designated by the Board of Directors, no boats or trailers shall be parked or left unattended on any part of the roadways or other Common Areas of the Property. The Board of Directors may, in its discretion, from time to time adopt and promulgate such additional Rules and Regulations regarding vehicle traffic and parking as it may consider appropriate.

Luminaries Scheduled for Dec. 11

The 12th annual Chesapeake Village Luminaries event is scheduled for Saturday, Dec. 11. This is the annual event where we line the village streets with lighted white bags and collect money and items for a selected charity. We will also get a visit from Santa Claus riding on the back of a North Beach VFD fire truck!

We are in need of volunteers for this event. We will need help on the assembly teams (no one is too young or too old!) and the driving teams (people with trucks, trailers, SUVs). The lighting will begin promptly at 6 p.m.

Community Improvement Committee's Current Focus is on Village Beautification
