Help Wanted: ARC, Social Committee Members

The HOA Board of Directors is looking to fill volunteer positions on the Architecture Review Committee (ARC) and the Social Committee.

The Architecture Review Committee consists of homeowners in our

neighborhood who review requests to change the exterior appearance of homes. These requests include, for example, adding a deck, changing a door color, removing porch railings, building a shed, erecting a fence, putting in a pool, expanding a driveway, etc.

Currently, the HOA Board members have been serving in this capacity in the absence of committee members.

The HOA is also looking for a new

chairperson for the Social Committee, as well as people who would serve on this committee to help plan events in the neighborhood. Some of the events in the past have included a cornhole tournament, a Fourth of July parade, an Easter egg hunt, and a fall membership meeting.



Snow Removal

The HOA Board of Directors have awarded a snow removal contract with the landscaping contractor, Greener Visions. The company will remove snow from sidewalks that are adjacent to "common areas" in the neighborhood.

This would include the sidewalk on Cavalcade Drive near Middle Ground Court and the sidewalk on the western portion of Lawrin Court.

Homeowners are required by the Town of Chesapeake Beach to remove snow from the sidewalk that is immediately in front or to the side of their homes.

The town removes sidewalk snow on Chesapeake Village Boulevard from the neighborhood entrance to the first house.

FRIENDLY REMINDERS

NO PARKING ON
SIDEWALKS: The Town
of Chesapeake Beach
reminds us that parking
on sidewalks within the
town limits is against
town code and subject
to a \$100 fine per day.
The HOA covenants
also say that "no ...
wheeled vehicles or
toys shall be parked or
left unattended on any
sidewalk, pathway, or
walkway or on any part



of the roadways or other common areas ..."

KEEP RECEPTACLES OUT OF SIGHT: According to the HOA covenants, all trash and recycling containers need to have lids and "shall not be permitted to remain anywhere in view from public roadways except on days of trash collection."

NO CAMPERS, BOATS, OR TRAILERS: According to the HOA covenants, campers/recreational vehicles, boats, and trailers cannot be kept in the neighborhood. "The Board of Directors may, in its discretion, from time to time adopt and promulgate such additions rules and regulations regarding vehicle traffic and parking as it may consider appropriate."

KEEP UP APPEARANCES: According to the HOA covenants, "homeowners shall keep the lot, and the landscaping, buildings in good order and repair, and free of debris. Lawns shall be seeded and mowed, shrubbery trimmed, and painted or stained exterior surfaces repainted or restrained, all in a manner and with such frequency as is consistent with good property management."
