# Census 2020

### Be Sure to Fill Out Your 2020 Census Questionnaire

The United States counts every person living in the country every 10 years. Beginning in mid-March, every household in the country will receive an invitation to respond to the 2020 Census.

The census not only determines congressional representation, the numbers are used to determine how more than \$675 billion in federal funds are distributed.

Residents will be asked to respond online using a unique code. Households will still be able to respond by mail, and will also have the option of responding by telephone. Households that don't respond by early May will likely receive a visit by a census taker.

# **Did You Know?**

Some Points of Emphasis from the Village Covenants and By-Laws

# No structures should be erected by homeowners in the common areas.

Except as otherwise permitted by the provisions of this Declaration, no structure or improvement of any kind shall be erected, placed, or maintained on any common area except:

- Structures or improvements designed exclusively for community use, including without limiting the generality of the foregoing, shelters, benches, chairs, or other seating facilities, fences and walls, walkways, roadways, playground equipment, swimming pools, and tennis courts.
- Landscaping.
- Drainage, storm water, and utility systems and structures.



#### Common areas are not to be used for storage of personal property.

No portion of any common area may be used exclusively by any owner for personal gardens, storage facilities, or other private uses. There shall be no use of the common areas and landscaped areas except natural recreational uses that do not injure the common areas or the vegetation thereon, increase the maintenance thereof, or cause unreasonable embarrassment, disturbance or annoyance to owners in the enjoyment of the common areas and landscaped areas in the vicinity of their lots.



#### No hunting activities are allowed.

No discharge of any type of firearm, nor any type of trapping or hunting (including bow and arrows) shall be allowed on any part of the property, including the common areas, recreation areas, forest retention areas, etc.
